<p>Single Stranded DNase Activity (FAM-Labeled Oligo) - A 50 μl reaction in NEBuffer 2 containing a 10 nM solution of a fluorescent internal labeled oligonucleotide and a minimum of 50 units of <i>Bsu</i> DNA Polymerase, Large Fragment incubated for 30 minutes at 37°C yields <10% degradation as determined by capillary electrophoresis.</p>	Pass
